## **NEW BRAUNFELS SWAP MEET RULES**

1. **Vendor vehicles must have a Swap Meet windshield sticker placed inside the upper left windshield. Each vehicle must have the sticker to be parked in a Swap Meet space or the Car Corral. No entry will be permitted into the Swap Meet area without a sticker.**
2. Hours of admittance and exit are on the back of your windshield sticker. Vendors may enter spaces at 8:00 a.m. Thursday.
3. Vendors may resell their Swap Meet Space only one time during the Swap Meet. We ask that you notify one of the Swap Meet Staff Members when you have sold your Space or Spaces. Vendors may not be allowed to sell their Space higher than Swap Meet Price.
4. Current vendors must renew spaces by May 31<sup>st</sup>. No cancellations will be accepted after March 15<sup>th</sup>.
5. Swap Meet spaces are marked with paint on the ground at all four corners and have a **Numbered Flag In The Center Front.** All items must be kept within these boundaries.
6. **To hold noise to a minimum, there will be no traffic from 10:00 p.m. to 7:00 a.m. RV generators will be allowed, but must be quiet and not disturb the other Vendors. There is round-the-clock security for vendors.**
7. Parking, for a reasonable time, in the Swap Meet area is authorized for loading and unloading only. All others will be towed. Unattended vehicles in unauthorized spaces will be towed at owner's expense.
8. **No Traffic will be allowed IN or OUT between 10:00 AM and 5:00 PM, unless approved by Swap Meet Staff.** Speed limit in the Swap Meet area is five (5) miles per hour.
9. **During the hours of 8:00 AM thru 5:00 PM Friday, Saturday, and Sunday no riding is permitted on Bicycles, Go Carts, Motorized Bikes, 3 & 4 Wheel ATV, & Golf Carts in the Swap Meet area, except for handicap vehicles. Handicap vehicles must have a State or City disability sticker displayed in a prominent place on the vehicle.**
10. **NO PETS Allowed on Swap Meet and Car Show grounds except in the Vendor's Spaces.** By Order of the Comal County Fair Association.
11. No food or beverages will be sold in the Swap Meet area except by authorized concessionaires. Glass containers will not be permitted throughout the area.
12. **Free Parts Hauling.** For anyone needing Items hauled (within the Fair Grounds). Please go to the Hospitality Booth located in center of Swap Meet. **Must have the booth number where parts are to be picked up.**
13. According to City Ordinance, there will be no open fires or smoking under tents or canopies. All tents or canopies must Display a No-Smoking Sign, provided by the New Braunfels Swap Meet. All tents or canopies must have a Fire Extinguisher.
14. Clean-up crews will remove all unattended parts after 5:00 p.m. All unattended vehicles left on Swap Meet grounds after 5:00 p.m. Sunday will be towed away at owner's expense. Spaces must be left free of all litter including cigarette butts, bottle caps and can tabs. Vendors leaving behind litter may be denied future rental of spaces.
15. Sale or exhibition of firearms will not be permitted within the Swap Meet area.
16. Lost persons are urged to use the Swap Meet headquarters for a meeting place.
17. Neither the New Braunfels Area Car Club nor the Comal County Fair Association will be responsible for damages, injuries or accidents during the Swap Meet.
18. Swap Meet officials reserve the right to reject and/or eject any person or firm they deem as undesirable for any reason. The officials' decisions are final.
